## A BILL

To modify the definition of armor piercing ammunition to better capture its capabilities.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Modernized Law En-  
5 forcement Officers Protection Act of 2015”.

1 **SEC. 2. ARMOR PIERCING AMMUNITION.**

2 (a) EXPANSION OF DEFINITION.—Section  
3 921(a)(17)(B) of title 18, United States Code, is amend-  
4 ed—

5 (1) in clause (I), by striking “or” at the end;

6 (2) in clause (ii), by striking the period and in-  
7 serting “; and”; and

8 (3) by adding at the end the following:

9 “(iii) a projectile that—

10 “(I) may be used in a handgun;

11 and

12 “(II) the Attorney General deter-  
13 mines, under section 926(d), to be ca-  
14 pable of penetrating body armor.”.

15 (b) DETERMINATION OF CAPABILITY OF PROJEC-  
16 TILES TO PENETRATE BODY ARMOR.—

17 (1) IN GENERAL.—Section 926 of such title is  
18 amended by adding at the end the following:

19 “(d)(1) The Attorney General, in consultation with  
20 Director of Operational Test and Evaluation of the De-  
21 partment of Defense, shall promulgate standards for the  
22 uniform testing of projectiles against the Body Armor Ex-  
23 emplar.

24 “(2) The standards promulgated under paragraph  
25 (1) shall take into account, among other factors, vari-  
26 ations in performance that are related to the type of hand-

1 gun used, the length of the barrel of the handgun, the  
2 amount and kind of powder used to propel the projectile,  
3 and the design of the projectile.

4 “(3) In paragraph (1), the term ‘Body Armor Exem-  
5 plar’ means body armor that the Attorney General deter-  
6 mines meets minimum standards for the protection of law  
7 enforcement officers.”.

8 (2) TIMING OF PROMULGATION OF STAND-  
9 ARDS.—The Attorney General shall promulgate the  
10 standards required by section 926(d) of title 18,  
11 United States Code, within 1 year after the date of  
12 the enactment of this section.

13 (3) ASSESSMENT AND MODIFICATION OF  
14 STANDARDS.—The Attorney General shall assess the  
15 standards every 3 years, or more frequently if the  
16 Attorney General finds that technological advances  
17 warrant doing so, and shall modify the standards as  
18 appropriate.
