## A BILL

To provide for United States security cooperation with Bahrain.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Bahrain Security Co-  
5 operation Improvement Act”.

6 **SEC. 2. SENSE OF CONGRESS ON UNITED STATES SECURITY**  
7 **COOPERATION WITH BAHRAIN.**

8 It is the sense of Congress that—

1           (1) it is in the national security interest of the  
2 United States to maintain a strong relationship with  
3 Bahrain and support its military efforts;

4           (2) Bahrain has a critical role as host of the  
5 United States Navy's Fifth Fleet and the United  
6 States Naval Forces Central Command;

7           (3) Bahrain is a major defense and security co-  
8 operation partner of the United States, as recog-  
9 nized when the United States designated Bahrain as  
10 a major non-NATO ally in 2002;

11           (4) there should be an increase in exchanges be-  
12 tween defense officials and law enforcement of the  
13 United States and Bahrain at the strategic, policy,  
14 and tactical levels, especially for the purposes of—

15                   (A) enhancing cooperation on defense plan-  
16 ning;

17                   (B) improving intelligence sharing to com-  
18 bat terrorism; and

19                   (C) improving interoperability between the  
20 Ministry of Interior and the United States  
21 Navy's Fifth Fleet;

22           (5) the United States should ensure Bahrain  
23 has capabilities with regards to its air, missile, and  
24 unmanned aerial system defense assets to support  
25 peace efforts in the region;

1           (6) it is important for the United States to be  
2 a source of consistent and reliable defense assets for  
3 Bahrain;

4           (7) the United States should deepen interoper-  
5 ability with Bahrain in defense capabilities, includ-  
6 ing—

7                   (A) maritime and air domain awareness;

8                   (B) integrated air and missile defense sys-  
9                   tems; and

10                   (C) counter unmanned aircraft system  
11                   measures;

12           (8) the Secretary of Defense should prioritize  
13 including Bahrain in military exercises to the great-  
14 est extent possible, increasing security cooperation  
15 and readiness between Bahrain and the United  
16 States; and

17           (9) it is in the best interest of the United  
18 States and Bahrain to work together to oppose any  
19 efforts of terrorism or radical extremism in the Mid-  
20 dle East.

21 **SEC. 3. REPORT ON UPGRADING CAPABILITIES OF UNITED**  
22 **STATES FIFTH FLEET.**

23           (a) IN GENERAL.—Not later than 180 days after the  
24 date of the enactment of this Act, the Secretary of Defense  
25 shall submit to the congressional defense committees a re-

1 port on upgrading the capabilities of the United States  
2 Fifth Fleet to address emerging threats in the region of  
3 the area of responsibility of the Fifth Fleet and any cost  
4 associated with such capability upgrades. Such report  
5 shall include an assessment of the efforts of the Depart-  
6 ment of Defense to—

7           (1) increase exchanges between defense officials  
8           and law enforcement of the United States and Bah-  
9           rain at the strategic, policy, and tactical levels, espe-  
10          cially for the purposes of—

11                   (A) enhancing cooperation on defense plan-  
12                   ning;

13                   (B) improving intelligence sharing to com-  
14                   bat terrorism; and

15                   (C) improving interoperability between the  
16                   public security forces and the United States  
17                   Fifth Fleet;

18           (2) ensure that Bahrain has capabilities with  
19           regards to its air, missile, and unmanned aerial sys-  
20           tem defense assets to support peace efforts in the re-  
21           gion; and

22           (3) deepen interoperability with Bahrain in de-  
23           fense capabilities, including—

24                   (A) maritime and air domain awareness;

1 (B) integrated air and missile defense sys-  
2 tems; and

3 (C) counter unmanned aircraft system  
4 measures.

5 (b) CONGRESSIONAL DEFENSE COMMITTEES DE-  
6 FINED.—In this section, the term “congressional defense  
7 committees” has the meaning given that term in section  
8 101 of title 10, United States Code.
